Economy and business structure

The UK is the 5th largest economy in the world and Finland's 7th largest export partner. The UK has made conscious steps to attract more businesses and has announced the desire to be "the most business-friendly country in the world". The corporation tax is currently 25%. There are no barriers to doing business in the UK. Language and culture pose no difficulties for Finnish companies. World Bank rates the UK tax system as the most business-friendly of the 10 largest economies in Europe, in terms of rates and administrative burdens. In terms of stability and quality of the system, UK is one of the top countries in the world. Due to its size, the UK is easy to navigate. There are no geographical restrictions due to excellent transport infrastructure.

The UK is the largest market for financial services in Europe.
